ELIGIBILITY

Works in any 2D medium, including photography qualify. (No 3D at this time) All works must be original and must be ready to exhibit (ie. framed ready to hang/no saw tooth hangers) and completed within the last 5 years. Maximum size limit of 4' x 4'. Must be a resident of Indiana.

INSURANCE

All works will be insured from their delivery to their departure from the BCAC. **Please provide value of artwork, if not for sale.**

SALES AND COPY RIGHTS

Sales are encouraged. A 30% commission will be charged on all works purchased. Your entry grants permission to photograph your work to use for promotional or educational purposes only. Artists who are awarded the cash prizes grant the right for the BCAC to photograph the artists with his/her work. Artwork that is purchased must remain throughout the duration of the exhibition.

ENTRY DETAILS

JUROR BIOGRAPHY • CARL SCHAFER

Carl is a trained art historian whose 25+ year career in the museum profession has focused on designing exhibitions and caring for works of art in virtually all materials and representing the world's major civilizations across time. Prior to his purchase of Muncie's Gordy Fine Art and Framing in 2015, he was Associate Director of Ball State's David Owsley Museum of Art from 2006-2015. That experience informs his work as a gallery owner and as a craftsman restoring and replicating antique picture frames. Carl works with several museum clients and also enjoys working with individual clients to preserve and frame their family treasures. He has also worked as a community leader as the founding president of the Muncie Arts and Culture Council, promoting the activities of arts organizations in Muncie. Carl currently sits on the Mayor's Arts Awards Committee and on the board of Muncie Downtown Development Partnership.
