ELIGIBILITY

Works in any 2D medium, including photography qualify.
(No 3D at this time) All works must be original and must be ready to exhibit (ie. framed ready to hang/no saw tooth hangers) and completed within the last 5 years. Maximum size limit of 4' x 4'. Must be a resident of Indiana.

INSURANCE

All works will be insured from their delivery to their departure from the BCAC. **Please provide value of artwork, if not for sale.**

SALES AND COPYRIGHTS

Sales are encouraged. A 30% commission will be charged on all works purchased. Your entry grants permission to photograph your work to use for promotional or educational purposes only. Artists who are awarded the cash prizes grant the right for the BCAC to photograph the artists with his/her work. Artwork that is purchased must remain throughout the duration of the exhibition.

JUROR BIOGRAPHY • KATHRYN ARMSTRONG

Kathryn Armstrong has been the executive director of the Columbus Area Arts Council (CAAC) in Columbus, Indiana since 2016. As a cultural leader and visual artist, Armstrong's work is centered around making communities stronger through art, culture and civic engagement. During her tenure with CAAC, she has implemented artist-led workshops, pop-up performances, and a community arts gallery and cultural space in downtown Columbus. In addition to these programs, Armstrong has increased opportunities for young talent to work with professional artists, designers and creative entrepreneurs.

Before relocating to Columbus, Armstrong held a faculty position for six years at the Herron School of Art and Design in Indianapolis, Indiana where she taught professional practice courses for undergraduate and graduate students. During this time, she also served as the Director of the Basile Center for Art, Design and Public Life. Armstrong earned an MFA in Visual Art and Public Life with, an emphasis in Sculpture from Herron School of Art and Design, a MA in Painting and Drawing from, Eastern Illinois University and BFA in Photography, with a minor in Film Studies from, Indiana University. Her work has been exhibited nationally and internationally, including several project-based residencies.
